# **SPPGA Winter Meeting**

January 3, 2016 Sacramento, CA

## I. Officer Reports:

- A. President Courtnie Braziel had nothing to report.
- B. Vice President J.T. Struthers had nothing to report.
- C. Treasurer Linda Henwood reported finances are in good shape even though our account is down from last year. Convention accounts have a healthy amount. We still owe the club 30% of the proceeds.
- D. Secretary Lynn Braziel passed out minutes of the previous meeting. They were approved as corrected by David. MSC JT/Elaine.

#### XI. Old Business:

- A. Awards for Shows: David would like us to return to awards being given at shows. Motion was made to bring back award money for shows at \$100.00/day for placing tickets and \$200.00/day for awards. MSC Elaine/Tammi. Elaine amended that it be reevaluated next January. Youth Show Chairs still need to ask for their money.
- B. Status of money to be transferred from the Convention account to SPPGA: It was decided at an earlier meeting and confirmed, the amount would be 30% of net.
- C. Donation to NPGA was discussed. It was decided to table this until next meeting when we know the status of NPGA's financial report due to lawsuit. There may also need to be additional expense by NPGA to update the computer system. Discussion followed about changes needed to make sure animal's full names are included on the papers with Master Champions and National Champions.
- D. Sponsorship of a Belt Buckle for Nevada County Fair's sanctioned restricted youth show: Lisa reported that the fair asked us to sponsor the senior pygmy goat showman at about \$140.00 to \$150.00. They need an answer by March 1<sup>st</sup> to be included in the fair book. No motion was made after discussion.
- E. Show Committee: JT suggested that we need to create a show committee to help with jobs at the shows. That way more people can be involved with helping. Discussion occurred resulting in having JT coordinate with the chair people to get volunteers for each of the shows. At shows volunteers will be asked for upcoming shows. Elaine has created a spread sheet.

#### XII. New Business:

- A. Annual audit should be held in January per our by-laws. Discussion was held suggesting show chairs turn in profit/expense spread sheets after each show. Kevin, David, Courtnie and Linda will look at the books.
- B. Judges gifts: Tammi would like to see us giving our judges a small gift to say thank you. Discussion followed. Elaine suggested that Barb Keisker bring some expense details to the next meeting.
- C. SPPGA Scholarship: Jennifer Lazoya would like to see us use the NPGA guidelines, plus be a member of SPPGA and attend at least one show in

order to apply. Applications would be sent to the youth coordinator selection by the club officers, and  $1^{\text{st}}$  place would receive \$250.00 with  $2^{\text{nd}}$  place receiving \$150.00. Discussion followed. Motion made to have a 2 year trial of a scholarship program and then reevaluate the success of it. MSC Elaine/ Alice

D. Quilt Squares will be available through Barbara Keisker for the next convention.

XIV. Papers: David reminded the membership that papers need to match the animal's markings regarding color code and all random markings since you can lose a championship if not.
